1. No alcohol consumed by anyone less than 21 years of age. Violations will result in early termination, no refunds.
2. No Smoking inside the Limo/Bus (unless pre-authorized), \$100 charge per incident.
3. Clean up fee for vomit is \$200 per incident.
4. All tolls and parking are not included in the rental rate.
5. All unruly persons will be dropped off at the sole discretion of the driver and no refunds will be provided.
6. We will not be responsible for any lost, damaged or stolen property.
7. No illegal drug use of any kind.
8. Overtime will be billed in hourly increments.
9. Cancellations must be made 14 days prior to your scheduled event to avoid being billed the full contract amount.
10. Customer agrees that a replacement vehicle may be substituted in the event of any unforeseen mechanical or medical issues, etc.

There is no guarantee the overtime hours will be available. Please be sure that the number of hours you are writing on the contract will be sufficient time for your event! All deposits are NON refundable. Company is not liable in the event of mechanical breakdown while on charter and will only be responsible for making up lost time at a mutually agreed date. The client assumes full financial liability for any damage to the vehicle caused during the duration of the rental by charteree or any members of their party. A fee of 100.00 for each carpet or seat burn. Sanitation fee is 250.00. Illegal drug use is prohibited by law. Any fines will be paid for by the customer. The driver has the right to terminate run without refund (if there is blatant indiscretion on the part of the client(s). Smoking is not permitted in some of our vehicles and this is left to the discretion of the driver. Overtime pay will apply after the first 15 minutes of prearranged time described on this contract. Not responsible for delays or termination of trip during inclement weather or situations caused by unsafe roads or conditions (i.e. not salted, accidents, etc.). Not responsible for articles left in the vehicle. Balances and gratuity to be paid to the driver on the day of the trip, prior to departure.
